## What is this product?

### Type

This product is an investment trust company, which is a type of alternative investment fund.

### Objectives

- The Company aims to achieve long term capital growth by investing predominantly in equities and their related securities of Japanese companies.
- The Investment Manager will typically focus on those companies primarily listed on Japanese stock exchanges whose growth prospects are not fully recognised by the market ("growth at a reasonable price").
- The Investment Manager is not restricted in terms of size or industry of the underlying entities in which it invests.
- The Company may also hold cash or invest in cash equivalents including money market instruments, and is able to use derivatives for efficient portfolio management, gearing and investment purposes.
- The Company has adopted a variable management fee which is calculated by referencing performance relative to the TOPIX Total Return Index.

### Intended retail investor

This product is intended for retail investors with no specific financial expertise who are seeking long-term capital growth. Investors should be able to bear a loss to their invested capital. The product is intended to be a long-term investment. This product is open for an unlimited duration, however, continuation votes are held every three years at the Company's Annual General Meeting.

## What are the risks and what could I get in return?

### Risk Indicator



 The risk indicator assumes you keep the product for 5 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class. This rates the potential losses from future performance at a high level, and poor market conditions are very likely to impact the value that will be returned to you.

This product does not include any protection from future market performance so you could lose some or all of your investment. Overseas investments may be more volatile than established markets. The shares in the investment trust are listed on the London Stock Exchange and their price is affected by supply and demand. The investment trust can gain additional exposure to the market, known as gearing, potentially increasing volatility.
