Objectives and Investment Policy

Objective: The fund aims to achieve capital growth over the long term.

Investment Policy: The fund invests at least 70% (and normally 75%) of its assets, in equities of Indian companies listed in India, or non-Indian companies which do most of their business in India. The fund may also invest in money market instruments on an ancillary basis.

Investment Process: In actively managing the fund, the Investment Manager considers growth and valuation metrics, company financials, return on capital, cash flows and other measures, as well as company management, industry economic conditions, and other factors. The Investment Manager considers ESG characteristics when assessing investment risks and opportunities. In determining ESG characteristics, the Investment Manager takes into account ESG ratings provided by Fidelity or external agencies. The fund aims to achieve an ESG score of its portfolio greater than that of its benchmark. Through the investment management process the Investment Manager aims to ensure that investee companies follow good governance practices.

Derivatives and Techniques: The fund may use derivatives for hedging, efficient portfolio management and investment purposes.

Base Currency: USD.

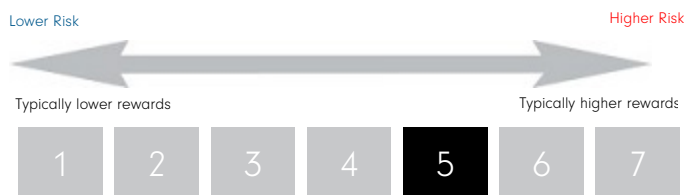
Benchmark: MSCI India Capped 8% index, a broad market index that does not take into account ESG characteristics. Used for: risk monitoring, and performance comparison.

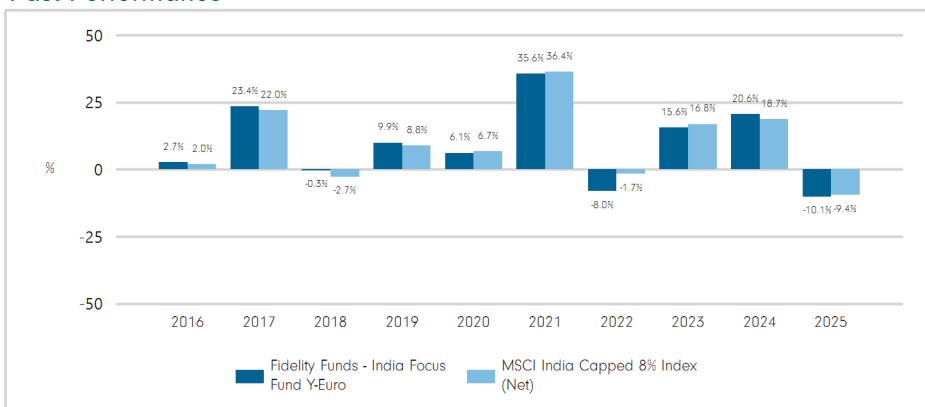
