Objectives and Investment Policy

Objective: The fund aims to increase the value of your investment over a period of 5 years or more without too much fluctuation in the short term.

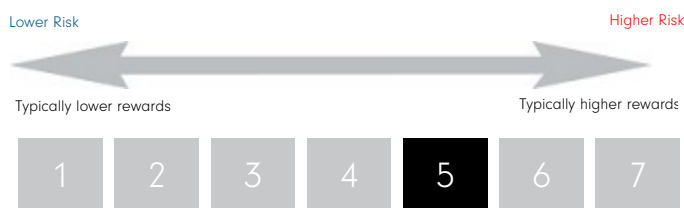
Investment Policy: Invests globally into a broad range of asset classes based on their risk profile. The fund can invest in funds (including funds managed by Fidelity), company shares, cash, deposits and derivatives. Asset allocation is managed using a systematic volatility and risk management process, typically involving increasing the fund's allocation to lower risk assets, e.g. government bonds, when market volatility rises and increasing the allocation to higher risk assets, e.g. equities, when market volatility falls. The fund can invest in bonds issued by governments, companies and other bodies.

Investment Process: The fund is actively managed without reference to a benchmark. The fund has full discretion in its choices of investments within its objectives and policies.

Derivatives and Techniques: Derivatives are investments whose value is linked to another investment, or to the performance of a stock exchange or to some other variable factor, such as interest rates and used to reduce risk or transaction costs and/or to generate extra income or further increase the value of your investment. The fund may also use derivatives with the aim of achieving the investment objective.

Additional Information: Income earned by the fund is paid into the fund and reflected by an increase in the value of each share. Shares can usually be bought and sold each business day of the fund. The fund's performance can be compared to the SONIA Index +3%.

This Fund is categorised in risk class 5 because, in accordance with the investment policy, the value of the investments may fluctuate somewhat sharply. Consequently, both the expected return and the potential risk of loss may be above average. The use of derivatives may result in "leverage" by which we mean a level of exposure which could expose the fund to the potential of greater gains or losses than would otherwise be the case. There is a risk that the issuers of bonds may not be able to repay the money they have borrowed or make interest payments. While we seek to mitigate this, the fund may be exposed to the risk of financial loss if it invests into an instrument issued by an entity that subsequently defaults on its borrowings. Losses may also be realised if an entity that the fund is exposed to ceases to make interest payments over a period of time or indefinitely. Bond prices have an inverse relationship with interest rates such that when interest rates rise, bonds may fall in value. Rising interest rates may cause the value of your investment to fall. The fund may be exposed to the risk of financial loss if a counterparty used for derivative instruments subsequently defaults.

The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

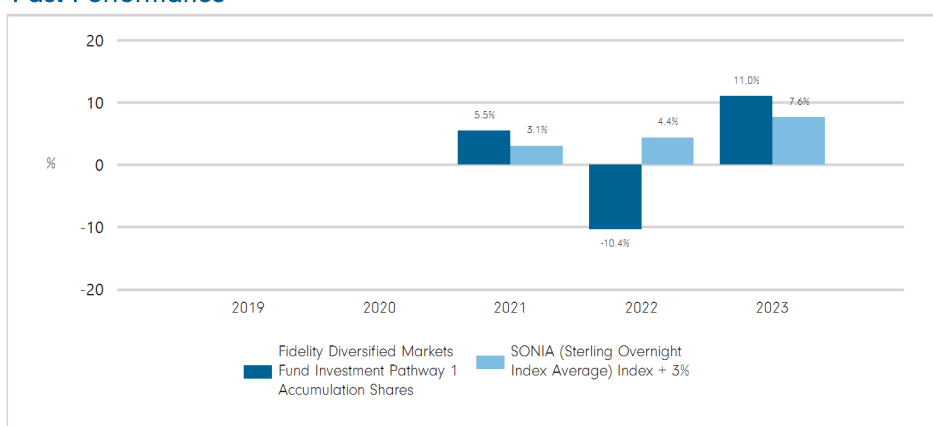
