Objectives and Investment Policy

The fund aims to increase the value of your investment over a period of 5 years or more from global exposure to a diversified range of assets.

The fund invests at least 80% into a portfolio of funds from the Fidelity Select 50 list of funds (which may include funds managed by Fidelity).

The fund has exposure to a balance of both higher risk assets (including non-investment grade debt instruments, equities, alternatives and commodities) and lower risk assets (e.g. investment grade debt instruments and cash).

The remainder will be invested in other investment types such as cash and derivatives.

Allocation of asset exposure will be actively managed subject to it remaining within the following parameters: 30-70% company shares, 20-60% debt instruments (e.g. bonds and emerging market debt) 0-20% commodities, 0-20% cash and 0-20% alternatives (such as infrastructure securities and Real Estate Investment Trusts). This may be tactically altered in accordance with the opportunities for producing returns over the market cycle while aiming to maintain a moderate risk profile.

Investment grade and non-investment grade debt instruments refer to bonds with a rating of BBB-/Baa or higher and BBB/Baa or lower, respectively, from an internationally recognised ratings agency.

Derivatives are investments whose value is linked to another investment, or to the performance of a stock exchange or to some other variable factor, such as interest rates and used to reduce risk or transaction costs and/or to generate extra income or further increase the value of your investment.

The fund may also use derivatives with the aim of achieving the investment objective.

The fund is actively managed without reference to a benchmark. The fund has full discretion in its choices of investments within its objectives and policies.

Income earned by the fund is paid into the fund and reflected by an increase in the value of each share.

Shares can usually be bought and sold each business day of the fund.


