Objectives and Investment Policy

Objective: The fund aims to increase the value of your investment over a period of 5 years or more.

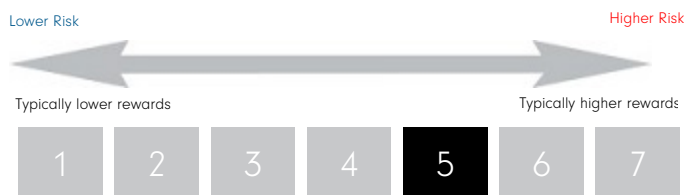
Investment Policy: The fund will provide at least 80% exposure to equities or equity related securities of companies (those domiciled, incorporated or having significant business) in the United Kingdom ("UK"). The fund may also invest a proportion of its assets in global companies listed in the UK. The fund typically seeks to gain exposure mainly by investing indirectly in other funds (including those operated by Fidelity), which may be index-tracking or actively managed, alongside direct investments. The fund may use derivatives for efficient portfolio management purposes or investment purposes and may hold liquid instruments. The fund may also invest in transferable securities, exchange traded funds, money market instrument, cash and deposits.

Investment Process: The fund is actively managed without reference to a benchmark.

Derivatives and techniques: Derivatives are investments whose value is linked to another investment, or to the performance of a stock exchange or to some other variable factor, such as interest rates and used to reduce risk or transaction costs and/or to generate extra income or further increase the value of your investment. The fund may also use derivatives with the aim of achieving the investment objective.

Additional Information: Income earned by the fund is paid into the fund and reflected by an increase in the value of each share. Shares can usually be bought and sold each business day of the fund. The typical investor in the fund will be a sophisticated investor. The fund's performance can be compared to the FTSE All-Share (Net Total Return) Index.

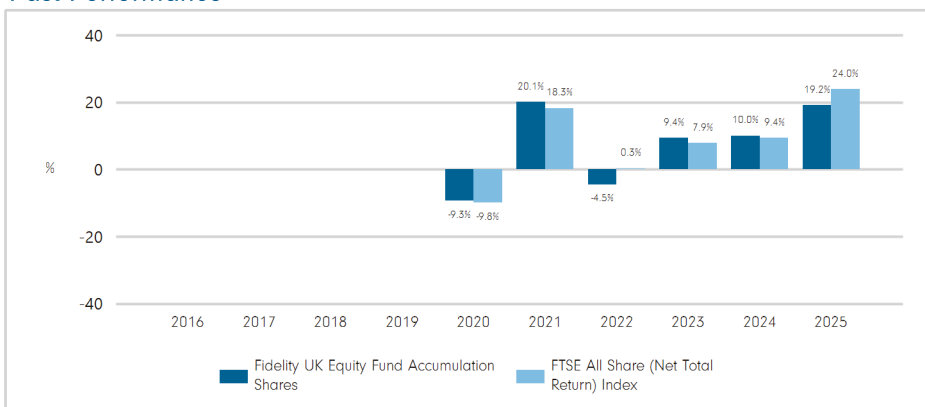
